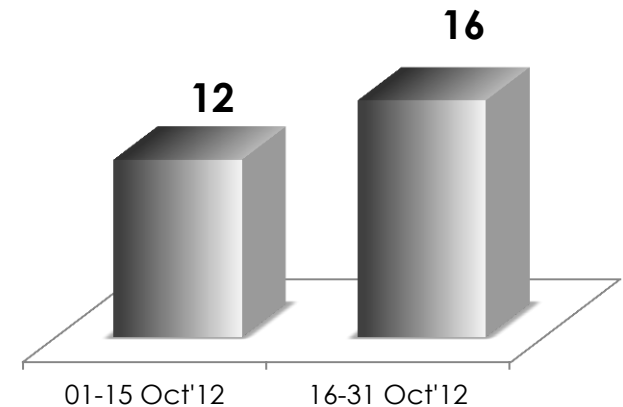

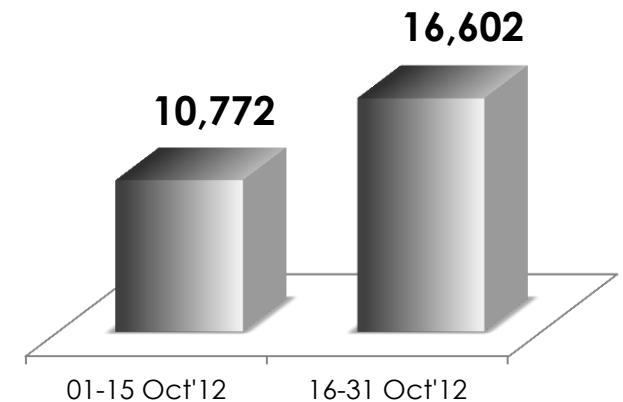
# PE Activity
